JUDGMENT

The applications for an extension of time are granted and the applications by Davis & Company, a partnership and by Robert C. Strother, *et al.* for leave to appeal from the judgment of the Court of Appeal for British Columbia (Vancouver), Number CA030145, 2005 BCCA 35, dated January 21, 2005, are granted with costs to the applicants in any event of the cause.

The application for an extension of time is granted. The application by 3464920 Canada Inc. (formerly known as Monarch Entertainment Corporation) for leave to appeal from the judgment of the Court of Appeal for British Columbia (Vancouver), Number CA030145, 2005 BCCA 35, dated January 21, 2005, is granted.
